# 1. Deductions from salaries

#### Scottish tax bands 2022/23

Band	Taxable income	Scottish tax rate
Personal Allowance	Up to £12,570	0%
Starter rate	£12,570 – £14,732	19%
Basic rate	£14,732 – £25,688	20%
Intermediate rate	£25,688 – £43,662	21%
Higher rate	£43,662 – £150,000	41%
Top rate	Over £150,000	46%

#### **National Insurance Contributions**

In the 2022–23 tax year, National Insurance payments varied during the year.

For payslips dated between 6 April 2022 and 5 July 2022, you began paying National Insurance once you earned more than £823 a month. The National Insurance rate you paid depended on how much you earned: 13.25% of your monthly earnings between £823 and £4189; 3.25% of your monthly earnings above £4189.

For payslips dated between 6 July 2022 and 5 November 2022, you began paying National Insurance once you earned more than £1048 a month. The National Insurance rate you paid depended on how much you earned: 13.25% of your monthly earnings between £1048 and £4189; 3.25% of your monthly earnings above £4189.

For payslips dated between 6 November 2022 and 5 April 2023, you began paying National Insurance once you earned more than £1048 a month. The National Insurance rate you paid depended on how much you earned: 12% of your monthly earnings between £1048 and £4189; 2% of your monthly earnings above £4189.

National Insurance is calculated on a person's salary **before deductions** such as pension contributions.

# 2. E10 Petrol

The following information is taken from the government's website *https://www.gov.uk/guidance/e10-petrol-explained* 

Petrol in the UK currently contains 5% renewable ethanol (known as E5) or 10% renewable ethanol (known as E10).

#### **Reducing emissions**

 $CO_2$  is one of the greenhouse gases that contribute to climate change and the main benefit of E10 petrol is that it reduces overall levels of  $CO_2$ -based vehicle emissions.

By blending petrol with up to 10% renewable ethanol, less fossil fuel is needed, helping us reduce carbon emissions and meet climate change targets.

The introduction of E10 petrol in the UK is predicted to cut transport  $CO_2$  emissions by 750 000 tonnes a year — the equivalent of taking 350 000 cars off the road.

Renewable fuel blends, such as E10 petrol, are generally introduced to reduce overall  $CO_2$  emissions. They have little impact on emissions associated with air quality and public health.

The production of renewable ethanol for blending with fossil petrol also results in valuable by-products, including animal feed and stored  $CO_2$ .

# Fuel economy

Using E10 petrol can slightly reduce fuel economy (the number of miles you are able to drive on a gallon of fuel). You may see a reduction of around 1%, but it is unlikely to be noticeable in everyday driving.

Other factors, such as your driving style or driving with under-inflated tyres or a roof rack, have a much more significant impact on fuel economy than using E10 petrol.

#### 3. Some helpful R commands

To read in data from an Excel csv file called *excel\_data.csv* to R Studio and name it *mydata*, first use the drop down menus in R Studio Session > Set Working Directory > Choose Directory to indicate the location of *excel\_data.csv* on your computer. The following code will then read the data in to R Studio:

mydata<-read.csv("excel data.csv")</pre>
```

attach (mydata) — this adds the variable names

At the end of the analysis remember to use detach (mydata) to disassociate the variable names.

#### (a) Graphics

hist(X,col="yellow",main="Histogram of X (units)") — this produces a histogram
of the variable X

plot(X,Y,xlab="x-axis label",ylab="y-axis label", main="Scatterplot of Y
on X",pch=21,bg="black") — produces a scatter plot of Y on X with the required title, axis
labels, and black dots

pie (table (X) , main="Title") — this gives a simple pie chart of the categories in variable X with the specified title

barplot(table(X), main="title", xlab="x-axis label", col="orange") — this
gives a bar chart of the categories in the variable X with the required title, axis labels and colour

boxplot(X) — produces a boxplot of the numerical variable X

#### (b) Descriptive Statistics

mean(X) — computes the mean of X

sd(X) — computes the standard deviation of X

 $\texttt{summary}\left(\mathtt{X}\right)$  — computes the mean, median, minimum, maximum, and upper and lower quartiles

table (X) — computes the number of observations in each level of the categorical variable X

 $\tt prop.table(table(X))$  — returns the proportion of observations in each level of the categorical variable X

<code>prop.table(table(X))\*100</code> — returns the percentage of observations in each level of the categorical variable X</code>

table (X, Y) — produces a cross-tabulation between the two categorical variables X and Y

# (c) Correlation and Regression

cor.test(X,Y) — computes the correlation between X and Y and performs a test of the null hypothesis of zero correlation

 $lm(Y \sim X)$  — fits a linear regression line to the data (lm command stands for linear model)

abline(lm(Y~X)) — produces a scatterplot with the least squares linear regression line superimposed on the data

summary(lm(Y~X)) — displays the coefficient of determination (r-squared)

#### (d) Hypothesis Testing

t.test(X,Y) — performs a two sample t-test between X and Y

t.test(X,Y,paired=TRUE) — performs a paired t-test between X and Y

prop.test(x = c(a, b), n = c(n1, n2)) — performs a 2-sample test for equality of proportions with continuity correction
